Hunterdon County's Economic Office Moving To Historic Chamber of Commerce Building

Hunterdon County's Economic Office Moving To Historic Chamber of Commerce Building Continuing Hunterdon County's process of advancing economic development operations towards a public private partnership, the Freeholder Board approved moving the Division of Economic Development offices to the Chamber of Commerce's historic Reading-Large House, at 119 Main St, in Flemington, at no rent cost to the County. Freeholder Board Director Matt Holt stated, "From its inception the plan for economic development is to become a public private partnership. Having the County's office located in the Chamber building, at no cost to the County, sends a strong message to the business community that the Chamber and the County are unified in our efforts." Freeholder Board Deputy Director Suzanne Lagay, the Board's liaison for Economic Development, pointed out, "The proximity with the Chamber allows the economic development initiative to work more efficiently with a prime project partner. We expect it will improve communication, aid in planning, and provide a single contact venue for the

business community." Freeholder John E. Lanza added, "In recognition of the County's significant investment of historic preservation funds in support of the rehabilitation of the Reading-Large House, and the importance of mutual cooperation in achieving economic development goals, the Chamber has agreed to charging no rent for the space, for which the Freeholder Board is most appreciative." Hunterdon County Chamber of Commerce President Chris Phelan said, "The Chamber of Commerce and Foundation are looking forward to having the County's Economic Development office move into the Chamber's headquarters and future home of the Center for Business, which is currently in construction. The collaboration with the County of Hunterdon strengthens our Business Community, with a goal of a vibrant economy that benefits all who work, live and visit our region." The Hunterdon County Economic Development office is presently located in Building #1 at the County Complex on Route 12 in Raritan. The office re-location will be completed by September.

NATIONAL SUICIDE PREVENTION AWARENESS MONTH

WHEREAS, suicide continues to be a serious but preventable public health problem that can have lasting harmful effects on individuals, families, and communities; and WHEREAS, nationally, suicide is the ninth leading cause of death overall and the third leading cause of death among Americans aged 5 to 14 and the second leading cause of death among Americans aged 15 to 24; and WHEREAS, most recent data shows that in New Jersey suicide has decreased to 9.7 self-inflicted deaths per 100,000 people demonstrating that through education and public awareness, suicide rates can improve; and

WHEREAS, the best way to minimize risk of suicide is to learn about risk factors, recognize warning signs and take them seriously, and know how to respond to possibly save a life; and

WHEREAS, National Alliance on Mental Illness – Hunterdon Chapter (NAMI Hunterdon) is proud to partner with Hunterdon County Stigma Free Task Force to end the bigotry against people afflicted with mental illness; and

WHEREAS, local suicide prevention efforts including Hunterdon's Stigma Free Task Force work to raise awareness, eliminate stigma, promote suicide prevention as a public health issue and increase help-seeking behavior; and

WHEREAS, effective prevention strategies are needed to promote awareness of suicide while also promoting prevention, resilience, and a commitment to social change; and WHEREAS, NAMI Hunterdon invites all residents and members of the Business Community of Hunterdon County to become educated about suicide and participate in National Suicide Prevention Awareness Month; and

NOW, THEREFORE, the Hunterdon County Chamber of Commerce, do hereby recognize September 2018 as NATIONAL SUICIDE PREVENTION AWARENESS MONTH AND BE IT FURTHER RESOLVED that the Hunterdon County Chamber of Commerce will call upon our membership to take the CureStigma test today to see if they are affected by stigma at CureStigma.org and pledge to be stigma free.



Tourism Spending Tops \$300 Million In Hunterdon County

"Just The Tip Of The Iceberg" Visitors to Hunterdon County spent \$317 million on tourism goods and services in 2016, a record amount of total tourism related receipts in the County, according to the **Tourism Impact Study** performed by the Lloyd Levinson Institute of Gaming, Hospitality, and Tourism at Stockton University that was presented to the Hunterdon County Freeholder Board on May 15th . Freeholder Board Director Matt Holt said, "The impact study report is positive and heartening news about tourism as an economic driver in the county and, most importantly, demonstrates that it is just the tip of the iceberg. There is tremendous room to grow the tourism element of the local economy." Dr. Brian Tyrrell, Associate Professor of Hospitality and **Tourism Management at Stockton** University, presented to the Freeholders the first phase of the three phase Tourism Study being conducted by the Levinson Institute, as part of the County's Economic Development strategy. The Hunterdon County Chamber of Commerce and the Delaware River Towns Chamber of Commerce and Visitors Bureau are partners with the County in the Tourism Study that is funded by a grant from the New Jersey Highlands Council. Dr. Tyrrell told the Freeholders, "Hunterdon County visitors spent \$317 million on tourism goods and services in 2016, a new record for tourism spending in the county. That included \$81.4 million in expenditures on food and beverage, the largest portion of tourism spending in Hunterdon County at 26%. That was followed closely by spending in the transportation sector at \$81.3 million





(26%), shopping (\$66.6 million or 21%), and traveler accommodations (\$36.8 million or 11%). Growth has been particularly pronounced in the spring and summer months. There were an estimated 2,865 individuals employed in the tourism industry in Hunterdon County during 2016. Hunterdon County tourism employment has been very stable over the past eight years, showing modest growth during the period. 2016 is the most recent year for which data is available." 2016 was the seventh consecutive year of rising tourism spending in Hunterdon. 2 Board of Chosen Freeholders County of Hunterdon 71 Main Street, Building #1 PO Box 2900 Flemington, NJ 08822-2900 MEDIA RELEASE Hunterdon County Economic **Development Director Marc Saluk** reported, "The County initiated a three phase Tourism Study to learn more about the real impact and viability of tourism locally and to determine a methodology for creating a sustainable effort to maximize Tourism economic development. > county, has begun and will be conducted during the visitor season, from April through October. And finally, phase three will be recommendations for an approach to creating sustainable and productive county wide tourism initiatives.

5 Common Social Security Questions Answered

There's no question that Social Security is a cornerstone of retirement income for many Americans. Yet, deciding when to take Social Security benefits is something that many people struggle with. As with most financial decisions, the right move depends on a variety of factors unique to each individual. If you are contemplating when to pull the trigger on Social Security benefits, read on for answers to some common questions.

At what age can I claim Social Security? As it stands today, Americans are eligible at age 62. If you start then, you will receive the lowest monthly benefit possible. The longer you delay claiming, the larger the benefit will be. The amount increases by eight percent each year. If you delay your claim, you should begin collecting by age 70 as monthly benefits do not increase after that point.1

What is my full retirement age? For years, full retirement age, or the age when you're eligible to receive your complete benefit from Social Security, was 65. It is now higher. For those born from 1943 to 1954, it is age 66; for those born between 1955 and 1959, it falls between ages 66 and 67; and for those born in 1960 or later, full retirement age is 67.1

What is the right age to claim benefits? The answer to this question varies depending on your circumstances. When deciding the timing that works for you, consider the following:

1. The likelihood of living a long life in retirement. According to the Social Security Administration, the average life expectancy for a person reaching age 65 is 84 for a man and just shy of 87 for a woman.

2. Your financial need for a regular source of income once you qualify to claim benefits. This may depend in part on whether you plan to continue working until you reach your full retirement age, or even after, in which case you may be able to delay taking Social Security benefits.

3. If you're married. For people with spouses, it's important to verify which of you will qualify for the larger benefit. Once one spouse dies, the surviving spouse will continue to collect the highest of the two benefits earned in the household.

Can I keep working and still collect Social Security?

Yes, but the Social Security Administration applies an earnings limit if you haven't yet reached full retirement age. In 2018, the limit for those who have not yet reached the year of their full retirement age is \$17,040. After you earn that much from work, your Social Security benefits will be reduced by \$1 for every two dollars you earn over the limit. In the year you will reach full retirement age, that limit rises to \$45,360. Once you surpass that amount, \$1 of your Social Security benefits is reduced for every \$3 you earn over the limit. After you have reached full retirement age, the earnings limit goes away. At that point, you can continue working and earn as much as you'd like without losing any Social Security benefits.2

How are my benefits determined? Benefits are based on your lifetime earnings, with an emphasis on the 35 years where you earned the most income. A formula is applied to those earnings to determine what you qualify to receive at full retirement age. This is the basis for determining any adjustment to your benefits if you claim prior to or later than your full retirement age.

These are a few of the factors that will affect the decisions you make on timing your Social Security benefits. If you have questions about your situation, contact your local Social Security office, visit www.ssa.gov or discuss this matter in more detail with a financial advisor.

taxtidbits

Effective October 1, 2018, New Jersey sales and use tax will be imposed on "transient accommodations". Transient accommodations include a room, a group of rooms, or other living /sleeping space for the lodging of occupants, which can include residential buildings. The following situations do not constitute a transient accommodation:

- · Places of assembly
- · Health care facilities
- School dormitories
- Campgrounds
- Leases of real property with a term of at least 90 consecutive days.

The new law essentially targets short-term housing rental, with a term of less than 90 days. Effective October 1, 2018, persons engaged in the business of providing transient accommodations in New Jersey through a marketplace facilitator, must charge sales tax on the rental income and ancillary charges. The most commonly known transient space marketplace facilitator is Airbnb. Rental of shore homes, during the summer months or ski chalets during the winter months, through a conventional realtor or other rental agency, would also be considered a marketplace facilitator.

A transient space marketplace does not include a marketplace operated by a hotel that facilitates hotel occupancy solely for the hotel's chain.

Keeping Electronics Protected from Storms and Electrical Occurrences By Donna De Vico, Zero Surge Inc.

As evidenced by the winter-like spring we had this year, there is nothing we can do about the weather. There is, however, much we can do to protect our electronics from the effects of bad weather and everyday power quality issues. Brownouts, sags, and electrical surges from equipment inside the building, like coffee pots, printers, vacuums, elevators, and even lights, cycling on/off wear down sensitive electronics.

For the last 20 years, I have witnessed all too often the damaging effects of power line surges on critical electronics and business operations. From a major fast food chain to a local accountant, business interruption and the associated expense is very costly. Improper surge protection can cause lost data, system lock-ups, inability to process transactions, downtime, lost customers, capital outlay for replacement equipment, and even fires. It's unfortunate, but many customers contact me after surge damage has occurred despite using what they thought was adequate "surge protection."



Over the last several years, however, I've noticed a major shift in why people contact Zero Surge. Most customers are now purchasing proactively rather than reactively, meaning they are protecting new or existing equipment before surge damage occurs. This is much like installing a security system before a burglary occurs. Surge protection is one of the most important purchases a business can make, but it is often misunderstood. Following are some guidelines for properly surge protecting your sensitive electronics.

First, determine which electronics are important to your business and if their loss would be detrimental to your operations (for example, computers, servers, point of sale systems, digital displays, A/V equipment, surveillance systems, fire alarm systems, PLCs). Second, decide where you want to put the surge protection:

• A plug-in point of use product simply plugs into the wall outlet closest to where the equipment is located (Fig. 1)

• Branch circuit protection for dedicated lines or hard-wired equipment is installed at the main panel by an electrician* (Fig. 2)

*Note – "whole building" surge protectors placed at the main panel do not protect sensitive electronics. Those manufacturers specify to use supplemental surge protection for sensitive electronics.

Next, consider the following criteria when making your brand selection:

· There are two main types of technology -- o Metal Oxide Varistor (MOV) based technology that diverts surges to the ground line. o Series Mode technology that filters surges without use of the ground line. • MOV based technology is not recommended for interconnected and networking equipment due to its ground line contamination. Series mode technology preserves the ground line and is recommended for interconnected and networking equipment. • Know the recommended replacement schedule for the model you are considering. MOV based surge suppressors wear out over time and require a replacement schedule of 6 mos.-3 yrs. depending upon the surge environment. Series Mode technology does not wear out or



degrade and requires no replacement schedule. • For the best protection, choose a model with the lowest Voltage Protection Rating (VPR) of <330 Volts and a Maximum Continuous Operating Voltage (MCOV) of 175 Volts. • Make sure it's certified to UL Safety Standards (UL 1283 for Series Mode technology, UL 1449 for MOV technology and, in addition, UL 1363 for both technologies if it has 3 or more outlets).


With proper surge protection, you can double the life of your sensitive electronics. Alternatively, lack of or improper surge protection can be devastating to the bottom line and have long term repercussions.
