Seven Steps to a Stronger Economy in 2019

An op-ed letter from NJ Chamber of Commerce President & CEO Tom Bracken (via ROI-NJ.com)

Gov. Phil Murphy campaigned on creating a “stronger and fairer” economy.

Since taking office, the governor and the Legislature have shown an energetic commitment in expediting initiatives for the fairer economy such as mandated paid sick leave, equal pay laws and the upcoming minimum wage increase. The components of the desired fairer economy are in place.

A substantial portion of the cost for these initiatives were borne by the business community, including increases in the corporation business tax, the tax on deemed repatriated dividends, the combined reporting mandate and the multimillionaire’s tax — all done at a time when the Tax Foundation had already ranked New Jersey’s business tax climate dead last in the nation.

These tax increases have compounded our significant issues of affordability and business competitiveness.

It is time now for the governor and the Legislature to focus on building the stronger economy with the same urgency, energy and commitment that was applied to the fairer economy in 2018.

This focus requires more attention be paid to our business community, its present state, its challenges and its needs.

New Jersey needs to be more affordable and more competitive; additional tax increases and mandates will not get us there. They must stop.

If we don’t begin serious and diligent efforts in the new year to build the robust economy we all need and want, the fairer economy will suffer and we will fall further behind in our efforts to rebuild our state’s economic power.



We strongly urge the governor and the Legislature to begin formulating and implementing plans so we can achieve an economic rebound.

There are substantive and dramatic actions we can take right away. Some of these ideas are included in Murphy’s Economic Master Plan and in Senate President Steve Sweeney’s Economic and Fiscal Policy Workgroup report on reducing the cost of government:

1. Take the billions of dollars of tax incentives that were offered to Amazon and make them available to small and medium-sized companies already in New Jersey;
2. Implement a capital gains tax to support the innovation economy;
3. Expedite the release of the monies in the Transportation Trust Fund to improve and build roads, bridges and mass transit — this also creates jobs and stimulates economic growth;
4. Implement recommendations from the Healey-Byrne report to reduce the swelling economic burden caused by the state’s ongoing pension funding issues;
5. Address the growing cost of government at all levels in New Jersey;
6. Hold our congressional representatives more accountable for getting additional net funding dollars from the federal government to relieve some of the pressures on our state budget; also be sure they are unified and focused on the Gateway Tunnel and Portal Bridge issues;
7. Focus more heavily on workforce development initiatives — we need the nation’s best trained and most highly qualified workers to have a competitive economy.

In 2019, the New Jersey Chamber of Commerce and other advocacy associations, through our coalition, Opportunity NJ, will make a series of recommendations that we believe can be implemented in the short term and that can lead us to a more robust and vigorous economy.

There is no dearth of good ideas that can help New Jersey prosper.

We need to put all the ideas on the table and create a plan that is doable. We need to implement this plan and we need to do it now. Tom Bracken is the CEO and president of the New Jersey Chamber of Commerce.

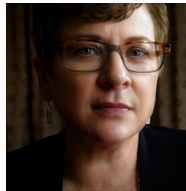

As 2018 winds down, it's time to think about if and how you may be able to reduce the taxes owed on your next tax return. New tax laws, which generally took effect on January 1 of this year, mean you may need to approach your tax strategy differently than you have in the past. Talk to your tax professional about whether the following five considerations apply to you:

1. Claiming the standard deduction or itemizing deductions

As in prior years, you have the option to either take the standard deduction (an amount set by law and adjusted for inflation) or itemize deductions. The new tax laws nearly doubled the standard deduction, which may make it more attractive for people to choose this option. For individuals, it is now \$12,000 (up from \$6,350 in 2017) and for married couples filing jointly it is \$24,000 (up from \$12,700 in 2017). Those age 65 or older or who are legally blind may claim an additional standard deduction of \$1,300 to \$1,600, depending on your filing status.

However, if your total available itemized deductions are nearing the amount of the standard deduction, you may want to take steps to qualify for additional or increased deductions. Donating to charity, making an additional house payment with mortgage interest or for medical expenses (subject to an AGI floor) are common itemized deductions. Incurring these expenses in this calendar year may allow you to reduce your taxable income by more than the standard deduction. Certain limitations and deductions may no longer be available to you, so review your situation with a tax advisor.

If you believe you'll be closer to the threshold in 2019, you may want to delay deductible expenses until next year to the extent you are able to do so. Going forward, it might be beneficial to bunch deductible expenses in alternating years to utilize the itemized deduction option when you can.

As you review your tax strategy, remember that if you claim the standard deduction on your federal return you may still be able to itemize deductions on your state income tax return.

2. Converting a traditional IRA to a Roth IRA

You can convert a traditional IRA to a Roth IRA anytime, however it may be more attractive to do so in this lower tax environment, particularly if you think you'll be taxed at the same or a higher rate in retirement. This is for two reasons.

First, you may avoid higher future taxes on the dollars earned in your Roth account. A Roth IRA differs from a traditional one because it is free from federal income taxes and the requirement to take a minimum distribution from the account after age 70 ½. This means you may be

able to keep more of your hard-earned retirement dollars.

Second, converting triggers federal taxes because you would be withdrawing the money (which is considered taxable income) from the traditional IRA to put it into the Roth account. If you convert this year, you will pay the lower 2018 rates on this additional taxable income. This is a perk to taking action now, if converting to a Roth IRA is a strategy you're considering.

3. Whether you are able to deduct state or local taxes

Under previous law, you were generally allowed to fully deduct your state and local income taxes (or state sales taxes, if elected) and property taxes from your income. Under the new law, the taxes are capped at \$10,000. This limit may impact your decision to itemize deductions.

4. If you qualify for a deduction as a business owner

If you are a business owner in a sole proprietorship, partnership, LLC or S corporation, a new tax provision may apply to you: Twenty percent of your qualified business income may be deductible from your income. Certain limitations apply, including those based on your line of business and taxable income. The rules around this are complex, so contact a tax advisor for additional information.

5. Reducing your taxable income

Many of the strategies previously used to reduce taxable income are still applicable under the new laws. A few to consider are:

- Deferring revenue into next year, if you're able to do so;
- Selling investments to generate capital losses that can help offset capital gains; and
- Increasing pre-tax contributions to workplace retirement plans to help boost savings while simultaneously reducing your current tax liability.

While it's always a good idea to be thoughtful about your tax strategy, the new tax laws mean it's important to prioritize reviewing your plan this year. Consult with a tax professional and financial advisor for guidance on the best financial strategy given your goals.



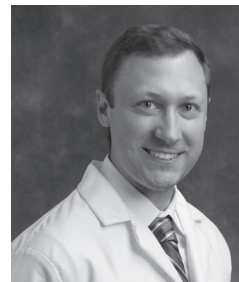

taxtidbits Retirement Savings Tax Deductions

With the loss of several itemized deductions under the new Tax Cuts and Jobs Act (TCJA) for many individuals, taxpayers are wondering where they can still find tax deductions. One great place is with retirement savings. The TCJA did not change the rules for retirement savings tax deductions. In fact, many retirement savings deductions continue to increase each year, due to inflationary adjustments.



For example, the maximum 401(k) or 403(b) annual retirement deduction is \$18,500 for 2018 (\$24,500 for taxpayers 50 or over). The maximum IRA contributions limit (which may or may not be deductible, depending on whether you or your spouse is covered by a retirement plan and on your total adjusted gross income amount) is \$5,500 (\$6,500 for taxpayers 50 or over), and you can still make your 2018 IRA contribution as late as April 15th, 2019. In addition, if you are self-employed, you can deduct up to 20% of your net self-employment income, to a maximum of \$55,000 (\$61,000 for taxpayers 50 or over) in a simplified employee pension plan (SEP), if you also cover any employees that you have working for your business. If you extend the filing date of your 2018 Form 1040 to October 15th, 2019, this extends the funding date of your 2018 SEP contribution to the October 15th date. Please note that all of the 2018 limits have been increased slightly for 2019, due to inflationary adjustments.

None of these rules are new but are often underutilized by individual taxpayers. There is a great advantage in funding the maximum available amount of retirement savings now. In addition, to getting a current tax deduction, you are deferring the taxability of the retirement income until you retire. Your retirement portfolio will grow tax deferred.

The rules for deductibility of certain retirement savings contributions can be quite complicated.
